**ORDER**

The complainants Sh. Sanjeev Chaudhary & others have got an electric connection under Op Sub-Division, UHBVN, Chachrauli and the Forum has the jurisdiction to hear this complaint.

It has been pleaded by the complainant that their stone crushers were closed by the HSPCB in March 2012 and their 3-Phase electric connections were disconnected by the Nigam on the request of HSPCB. Later they were allowed only single phase connection by the Nigam for light for security reasons in the night on their request. Their 3-phase connections were disconnected but still they are being charged Fixed Charges which should not be levied in the absence of 3- phase supply. They have requested that they may be exempted from levy of Fixed Charges and billing be done only on units consumed for light purposes.

The application of the petitioner was received in this office of the Forum on 7.1.13. The Forum considered the facts and found the petition feasible of acceptance and the same was admitted. Accordingly, notice of motion dated 11.1.13 was issued to all the parties asking complainants to submit affidavit and asking respondent to submit version.

The respondent SDO submitted the version dt. 7.1.13 which was found to be incomplete. The respondent SDO again submitted version dt. 22.2.13 stating that the complainants are consumer of HT Industrial supply. Their connections were disconnected as per the directions imparted by the Haryana State Pollution Control Board, Jagadhari through Deputy Commissioner, Yamunanagar which was communicated to XEn, Sub-Urban Division, UHBVN, Jagadhari vide memo dt 16.4.12. After disconnection, the complainants made a request to Higher Ups for giving single phase supply for security measures and accordingly single phase supply was restored. The Fixed Charges is one of the components of the Tariff Schedule for supply under which the billing is done and so charging of Fixed Charges cannot be dispensed with and is therefore payable by the complainants.
