ORDER


The complainant Sh. Jasbir Singh S/o Sh. Prem Singh, R/o Vill. Charuni Jatan, Tehsil Shahbad Markanda, Kurukshetra, has complained regarding Change of name of Tubewell Connection bearing A/c No. R1-0687 in SDO/OP, S/Division No. 1, UHBVN, Shahbad and Forum has the jurisdiction to hear this complaint.

The complainant has pleaded that his father Sh. Prem Singh got a Tubewell Connection No. R1-0657 in his name transferred in the name of his son Sh. Balvinder Singh without taking No Objection Certificate from the other two sons namely Jasbir and Surinder. The complainant wants that the transferred Tubewell connection no. R1-0657 be got stayed as there is a Land portition case pending with Commissioner Ambala and the above Tubewell Connection is installed on that Land.

The complaint was received in this office of the Forum on 19.03.13. The Forum considered the facts and found the petition feasible for acceptance and the same was got admitted. Further notice of motion dated 26.03.13 was got issued asking the complainant to submit the affidavit duly attested from Notary Public/Oath Commissioner which is mandatory as per HERC guidelines and respondents was asked to submit version/reply duly supported with attested affidavit from Notary Public/Oath Commissioner. The version of the respondent not received in time. So notice to both parties given for hearing issued on 30.04.13. Both the parties attended the hearing on 30.04.13 and the version was submitted by the respondent on 30.04.13.

The respondent stated as per his version that the Change of Name of Tubewell Connection in the name of Sh. Balvinder Singh has been done with the consent of owner Sh. Prem Singh as per instruction of the Nigam after observing all the formalities on 14.07.11. The connection was changed in the name of Sh. Balvinder Singh on the consent of legal occupants of the premises.

The Forum considered the facts as above and the complaint is hereby dismissed without any cost on either side. The order is signed by the Consumer Grievances Redressal Forum on 30.04.2013.
