

ORDER

The complainant Sh. Anil Kumar s/o Late Sh. Gandharb Singh, R/o H. No. 29-B, Prithvi Nagar, Jagadhari Workshop, Yamuna Nagar has pleaded regarding delay in completion of the deposit work i.e. shifting / removal of three phase LT overhead line passing / crossing over his plot and the Forum has the jurisdiction to listen to the complaint.

It has been pleaded by the complainant that an amount of Rs. 18805/- has already been deposited in 'OP' Sub-Division No. 1, UHBVN, Yamuna Nagar on 29.5.12 against the above said deposit work and has requested to get the remaining work completed at the earliest so that his able to start the construction of new house over the said plot without any danger to life from the overhead live LT line.

The complaint was received in this office of the Forum on 14.05.13. Forum considered the facts and found the petition feasible for acceptance and the same was admitted. Accordingly, notice of motion dated 20.05.13 was issued to both the parties intimating admission of his complaint for further proceedings and asking respondent to submit version.


Summon were issued to both the parties for hearing on 18.06.13. The respondent SDO was present whereas the complainant absented.

The respondent has stated in his version that the work could not be completed earlier due to non availability of material. An affidavit from the complainant has also been furnished. Wherein he has stated that the entire work has been completed to his entire satisfaction.

The Forum after considering all the facts decides that since the deposit work has been completed by the respondent to the satisfaction of the complainant, no further action is required to be taken by the respondent.

The complaint is disposed off without any cost on either side. File be consigned to the office record.
