ORDER

The complainant M/s Grasim Industries Ltd., (Ultra Tech. Cement Ltd.) on 33KV Independent Feeder complained against release of connection by SDO 'OP' Sub-Division, UHBVN, Israna to M/s Golden Taxo Fab. Ltd., Village Pardhana by tapping of Independent Feeder. The Forum has the jurisdiction to hear this complaint.

The complainant has pleaded that SDO/OP, Sub-Division, Israna is forcing them to give consent within 7 days for tapping 33KV Independent Feeder constructed by them to release connection to other consumers. They pleaded that reliability of supply to their plant will be affected, their IEX power as individual consumer as per HERC provision will be affected.


The complaint received in the office of the Forum on 26.09.2013. The Forum considered the facts and found the petition feasible for acceptance and same was admitted. Accordingly, notice of motion dated 05.11.2013 was issued to both the parties asking complainant to submit affidavit in support of his complaint and to the respondent to submit his version/reply supported with attested affidavit.

Since the version not submitted by the respondent in time so, the matter taken up for hearing fixed on 15.11.13 and 27.11.13 in UHBVN, Guest House, Rohtak.

The respondent during hearing confirmed that competent authority has sanctioned the tapping of their independent feeder keeping in view all the provisions of the Nigam circulars as well as HERC terms for open access of Power.

The Forum considered all the facts in the matter and found the complaint without any cause of action. The complaint is hereby dismissed without any cost on either side. File be consigned to the office record.

The order got issued and signed by the Consumer Grievances Redressal Forum on 29.11.2013.
