ORDER

The complainant Sh. Bhagwan Nath S/o SH. Shyam Sunder, R/o Mata Gate, Kaithal has complained regarding non shifting of wire of main line near his house by respondent ^{despite} deposit of estimate cost of Rs. 6915/- under SDO 'OP' Sub-Division No. 1, UHBVN, Kaithal and the Forum has the jurisdiction to hear this complaint.

The complainant has pleaded that electric line passing close to his house. An application to SDO he was asked to deposit Rs. 6915/- which he deposited on 05.04.13 vide receipt no. 359/77096 but the electric line not shifted till date.


The complaint received in the office of the Forum on 15.10.2013. The Forum considered the facts and found the petition feasible for acceptance and same was admitted. Accordingly, notice of motion dated 07.11.2013 was issued to both the parties asking the complainant to submit attested affidavit in support of his complaint and to the respondent to submit his version/reply supported with attested affidavit from Notary Public/Oath Commissioner.

Since the version was not received in time, the matter was taken up for hearing fixed on 12.12.13 in CGRF office at Panchkula. The respondent attended the hearing on 12.12.13 as well as submitted his version.

The respondent submitted as per his version that the shifting of main line in front of the house of the complainant has been shifted against deposit estimate of Rs. 6915/- and respondent also supplied undertaking on affidavit from the complainant in confirmation of the work done by the respondent.

The complaint is hereby disposed off without any cost on either side. File be consigned to the office record.

The order got issued and signed by the Consumer Grievances Redressal Forum on 12.12.2013.
