ORDER

The complainant Sh. Sunil Sharma S/o Sh. Anand Parkash, R/o Gomti Gali, H. No. 1441, Jagadhari, Yamuna Nagar has complained regarding shifting of electric wire passing over the plot of the complainant and the Forum has the jurisdiction to try this complaint.

It has been pleaded by the complainant that high voltage electric wires a passing over his shop and that he had approached the concerned SDO/XEN on numeral occasions and the wires and the pole have not been removed from the plot. It has further been pleaded by the complainant that the poles and the wires may be taken out of his premises without any further delay.

The complaint was received in this office of the Forum on 21.10.13. Forum considered the facts and found the petition feasible for acceptance and the same was admitted. Accordingly, notice of motion dated 07.11.13 was issued to both the parties asking complainant to submit affidavit and asking respondent to submit his version. Summons were issued to both the parties for hearing on 12.12.13.

The respondent has stated in his version that the area incharge of this office visited the site and framed the deposited estimate amounting to Rs. 8920/- and the intimation has given to the complainant vide memo no. 1935/4-10-13. The 11KV line was erected by the respondent long ago and the construction was raised by the complainant after erection of the line. The deposited estimated was prepared and intimation has been given to the complainant to deposit the amount but the same has not been deposited till date. As such the line has not been shifted

The Forum considered all the relevant record / facts in the case and decide that further action needs to be taken by the respondent only after the deposit of the estimate amount by the complainant which already stands intimated to the petitioner by the complainant.

The Forum disposes off the complaint without any cost on either side. File be consigned to the office record.
