**Subject: Regarding payment of Dearness Allowance to UHBNV employees on revised scale of pay.**

The UHBNV is pleased to adopt the Haryana Government, Finance Department Order No. 4/3/2016-5FR/9986 dated 08.06.2018 (copy enclosed) vide which the rates of dearness allowance to its employees on the revised scales of pay has been enhanced from the existing rate of 5% to 7% of the pay w.e.f 01.01.2018.

Sir/Madam,

I am directed to invite reference to Finance Department circular letter No. 4/3/2016-5FR/30416 dated 23<sup>rd</sup> October, 2017 on the subject noted above and to say that the Governor of Haryana is pleased to decide that the Dearness Allowance payable to Haryana Government employees on revised scales of pay shall be enhanced from the existing rate of 5% to 7% of the pay w.e.f. 1<sup>st</sup> January, 2018.

2. The installment of Dearness Allowance payable under these orders shall be paid in cash to all Haryana Government employees with the salary for the month of June, 2018 to be paid in July, 2018.
3. The payment of arrears of enhanced Dearness Allowance for the month from January, 2018 to May, 2018 shall be made in the month of July, 2018.
4. The provisions contained in para 3,4,5, & 7 in FD's instruction No. 4/3/2016-5FR/35222 dated 25<sup>th</sup> November, 2016 shall continue to be applicable while regulating Dearness Allowance under these instructions.
