The State Govt. (Finance Department) vide their letter no. 4/2/2009-5FR (FD) dated 20/06/2018 with reference to its earlier letter No. 4/2/2009-5FR (FD) dated 27/08/2014 has revised the existing rate of special Allowance to all Safai Karamchari working in the various Departments/Public Undertakings/Municipal Committee in the State @ 625/- ( Rs.
