

Sir/Madam,

I am directed to invite reference to Finance Department circular letter No. 4/3/2016-5FR/9986 dated 8<sup>th</sup> June, 2018 on the subject noted above and to say that the Governor of Haryana is pleased to decide that the Dearness Allowance payable to Haryana Government employees on revised scales of pay shall be enhanced from the existing rate of 7% to 9% of the pay w.e.f. 1<sup>st</sup> July, 2018.

2. The instalment of Dearness Allowance payable under these orders shall be paid in cash to all Haryana Government employees with the salary for the month of September, 2018 to be paid in October, 2018.
3. The payment of arrears of enhanced Dearness Allowance for the month from July, 2018 to August, 2018 shall be made in the month of October, 2018.
4. The provisions contained in Para 3,4,5, & 7 in FD's instruction No. 4/3/2016-5FR/35222 dated 25<sup>th</sup> November, 2016 shall continue to be applicable while regulating Dearness Allowance under these instructions.
