Uttar Haryana Biji Vitran Nigam is pleased to enhance the Dearness Allowance to the Nigam employees from the existing rates of 295% to 312% on the pre-revised pay scale/grade pay w.e.f. 01.07.2019 as contained in Haryana Government, Finance Department Order No. 4/1/2009-5FR/3352 dated 13.02.2020 (Annexure-A). The other terms and conditions contained in the notification dated 13.02.2020 shall remain unchanged.
