3. The officer at Sr. No. 1 would have continued to officiate as Dy. Superintendent but for her promotion as Superintendent.

6. In case handing/taking over reports of above officers are not received within 7 days, their pay may be withheld by the CAO (P&A) till the compliance of orders is made.
