1. 2. The officer at Sr. No. 1 will remain on probation for a period of one year from the date of assumption of charge of Sr. Accounts Officer or till attaining the age of superannuation whichever is earlier.
3. The officer at Sr. No. 1 would have continued to officiate as Accounts Officer but for his promotion as Sr. Accounts Officer.
