Note :-

1. The above officials on their promotion to the rank of UDCs will have no claim of seniority over those who are otherwise senior to them and whose cases could not be finalized due to pending disciplinary proceedings/ Court cases or final decision of seniority or any other reasons what-so-ever. They are liable for reversion without any notice to make room for their seniors, if need be, in terms of state Government circular No 26/59/80/I GSI dated 22.9.80 and without prejudice to the pending court cases, if any.
2. The above officials will remain on probation for a period of one year from the date of assumption of charge of UDC or till attaining the age of superannuation which ever is earlier.
3. The above officials would have continued to officiate as LDC, but for their promotion as UDC.
4. The above official may be relieved immediately without waiting any substitute/making any back reference to join the new assignment immediately.
5. The pay of the above officials will be charged against the vacant post of UDC.
