Sh. Vivek was appointed as AE/Electrical vide officer of appointment letter No. Ch-2/UH/HR-II/EBG-759 dated 18.02.2021, he has joined in UHBVNL on 19.03.2021. Sh. Vivek submitted his resignation letter dated 07.06.2021 stating therein that he has selected as Senior Engineer in Samsung, Korea in the higher scale and as such his resignation w.e.f. 07.06.2021 may be accepted.

As per clause 2(b) of the terms & conditions of appointment letter dated 18.02.2021, Sh. Vivek executed a bond that he will serve in the Nigam for a minimum period of two years after completion successful training, failing which he will be required refund to the Nigam the entire pay & allowances etc. and any other expenditure incurred by the Nigam together with interest thereon from the date of demand @ 9% per annum during the period training and thereafter during the course of employment under the Nigam but he has only served as AE/Electrical (Trainee) w.e.f. 19.03.2021 to 07.06.2021 (EOL w.e.f. 22.03.21 to 28.05.21) i.e. less than the minimum prescribed period of two years.
